1. GENERAL INFORMATION

1.1. Introduction

2. PROCESSING OF PERSONAL DATA DURING YOUR USE OF OUR WEBSITE

This data is collected for the purposes of optimising and improving our website as well as our online services. We have taken appropriate measures to ensure that the data provided to us during the registration is adequately protected. 2.1. Contact Form

2.2. Cookies

2.3. Data Recipients

We may use third party service providers to process your Personal Information. These service providers may be in or outside of South Africa or in countries within and outside the European Union (EU) and the European Economic Area (EEA). We ensure that these service providers process Personal Information in accordance with European data protection guidelines or legislation to guarantee an adequate data protection level, even if Personal Information is transferred into a country outside the EEA for which no adequacy decision of the EU Commission exists. Transfers of Personal Information to other recipients is not performed, except where we are obliged to do so by law. 2.4. Retention Period

Personal Information provided to us via our website will only be stored until the purpose for which it was processed has been fulfilled. Insofar as retention periods under commercial and tax law must be observed, the storage period for certain data can be up to 5 years. However, storage periods may also be amended due to our legitimate interest (e.g., to guarantee data security, to prevent misuse or to prosecute criminal offenders).

- The right to withdraw a given consent at any time to stop data processing that is based on your consent.
